

COUNCIL MINUTES
JANUARY 12, 2016

THE COMMON COUNCIL OF THE CITY OF MONDOVI MET IN THE COUNCIL CHAMBERS OF CITY HALL FOR THEIR FIRST MEETING OF THE MONTH. MAYOR TREIG PRONSCHINSKE PRESIDED OVER THE MEETING WITH ALL MEMBERS PRESENT EXCEPT COUNCILWOMAN LARSON.

A MOTION WAS MADE BY COUNCILMAN LUBINSKY AND SECONDED BY COUNCILMAN JOHNSON TO ACCEPT THE AGENDA AS POSTED. MOTION CARRIED.

COUNCILMAN RUD WANTED IT NOTED THAT COUNCILWOMAN SMITH REMAINED IN THE COUNCIL ROOM WHEN SHE EXCUSED HERSELF FROM THE COUNCIL CHAIR AT THE 12/8/2015 COUNCIL MEETING. SMITH REFERRED TO THE LEAGUE OF WISCONSIN MUNICIPALITIES HANDBOOK FOR WISCONSIN MUNICIPALS FOR RULES ON THE MATTER.

COUNCILMAN KRISIK OBJECTED TO COUNCILMAN RUD'S REGULAR DIVISIVE ACTIONS. RUD FELT THERE ARE ILL FEELINGS AMONG THE COUNCIL THAT MAY BE DIFFICULT TO OVERCOME.

KRISIK COMMENTED, "IT STARTS FROM HERE." WHEN ASKED TO EXPLAIN, KRISIK SHARED AN INSTANCE TWO TO THREE MONTHS AGO, WHEN RUD WAS OUT TRYING TO DISBAND THE CITY LAW ENFORCEMENT IN THE CITY OF MONDOVI. RUD AFFIRMED HE WAS LOOKING TO CUT COSTS FOR THE CITY.

KRISIK BELIEVES THERE IS A PERSONAL AGENDA FROM A FAMILY FALLING OUT WITH THE MAYOR, WHICH RUD BRINGS IN TO COUNCIL MEETINGS AND WHENEVER HE CAN ATTACK THE MAYOR OR SOMEBODY ON THE COUNCIL THERE IS A LACK OF RESPECT SHOWN. KRISIK WOULD LIKE IT TO END AND NOTED IT FOR THE RECORD.

A MOTION WAS MADE BY COUNCILMAN HOLDEN AND SECONDED BY COUNCILMAN LUBINSKY TO APPROVE THE DECEMBER 8, 2015 COUNCIL MINUTES. MOTION CARRIED.

A MOTION WAS MADE BY COUNCILMAN KRISIK AND SECONDED BY COUNCILMAN JOHNSON TO TABLE HIRING MARKETING EDGE LLC (EMILY MATCHEY) TO MAINTAIN THE CITY WEBSITE. MOTION CARRIED.

BOBBY LUBINSKY ASKED ABOUT FUTURE PLANS FOR BUSINESS GROWTH IN MONDOVI. SOME THOUGHTS AND IDEAS DISCUSSED WERE:

A MOTION WAS MADE BY COUNCILMAN KRISIK AND SECONDED BY COUNCILMAN RUD TO SEND POLICE CHIEF SMITH'S PROPOSAL FOR SECTION 10.07 (6) RELATING TO THE PROHIBITION OF DEPOSITING DEBRIS OR WASTE MATERIAL ON PUBLIC OR PRIVATE PROPERTY AND CHAPTER 9 REGARDING ORDERLY CONDUCT TO LEGAL COUNCIL TO PREPARE A FORMAL CHANGE. MOTION CARRIED.

A MOTION WAS MADE BY COUNCILWOMAN SMITH AND SECONDED BY COUNCILMAN RUD TO NOT VACATE SHORT STREET NEXT TO MONDOVI HOUSING AUTHORITY. MOTION CARRIED.

A MOTION WAS MADE BY COUNCILMAN JOHNSON AND SECONDED BY COUNCILMAN HOLDEN TO APPROVE OPERATOR LICENSE FOR KAYLEE J. CATURIA (HANSEN'S IGA). MOTION CARRIED.
