A MOTION WAS MADE BY COUNCILMAN LUBINSKY AND SECONDED BY COUNCILMAN JOHNSON TO ACCEPT THE AGENDA AS POSTED. MOTION CARRIED.

A MOTION WAS MADE BY COUNCILMAN ROBERT HOLDEN AND SECONDED BY COUNCILMAN RUD TO APPROVE THE FEBRUARY 10, 2015 COUNCIL MINUTES. MOTION CARRIED.
