

COUNCIL MINUTES
MARCH 22, 2016

THE COMMON COUNCIL OF THE CITY OF MONDOVI MET IN THE COUNCIL CHAMBERS OF CITY HALL FOR THEIR SECOND MEETING OF THE MONTH. IN THE ABSENCE OF MAYOR TREIG PRONSCHINSKE , COUNCIL PRESIDENT JERRY RUD PRESIDED OVER THE COUNCIL MEETING WITH ALL MEMBERS PRESENT EXCEPT COUNCILMAN HOLDEN.

A MOTION WAS MADE BY COUNCILMAN KRISIK AND SECONDED BY COUNCILMAN LUBINSKY TO ACCEPT THE AGENDA AS POSTED AND TO CHANGE THE LISTED ORDER OF OLD BUSINESS. MOTION CARRIED.

A MOTION WAS MADE BY COUNCILMAN LUBINSKY AND SECONDED BY COUNCILMAN JOHNSON TO APPROVE THE MARCH 8, 2016 COUNCIL MINUTES. MOTION CARRIED.

CITIZENS COMMENTS:

BRENDA GRUBER ASKED FOR A REPORT ON THE PIGEON ISSUE AND SHARED HER THOUGHTS ON A SOLUTION. DAN LAUERSDORF WILL CONTACT PLUNKETT'S PEST CONTROL FOR AN UPDATE AND PLACE THE TOPIC ON THE APRIL 12, 2016 AGENDA.

A MOTION WAS MADE BY COUNCILMAN RUD WITH NO SECOND TO THE MOTION TO APPROVE THE PARKING TICKET WAIVERS FOR SAFE RIDE RECIPIENTS ON A TRIAL BASIS FROM NOVEMBER 1, 2016 THRU APRIL 1, 2017. NO ACTION TAKEN UNTIL COUNCIL GETS MORE INFORMATION FROM COMMUNITIES WITH THE POLICY.
