

COUNCIL MINUTES
MAY 24, 2016

THE COMMON COUNCIL OF THE CITY OF MONDOVI MET IN THE COUNCIL CHAMBERS OF CITY HALL FOR THEIR SECOND MEETING OF THE MONTH. MAYOR TREIG PRONSCHINSKE PRESIDED OVER THE MEETING WITH ALL MEMBERS PRESENT.

A MOTION WAS MADE BY COUNCILMAN RUD AND SECONDED BY COUNCILWOMAN LARSON TO ACCEPT THE AGENDA AS POSTED. MOTION CARRIED.

A MOTION WAS MADE BY COUNCILMAN KRISIK AND SECONDED BY COUNCILMAN AVERY TO APPROVE THE MAY 10, 2016 COUNCIL MINUTES. MOTION CARRIED.

AFTER DISCUSSION ON JOB DESCRIPTIONS AND PERFORMANCE EVALUATIONS IT WAS DETERMINED THAT THE CURRENT JOB DESCRIPTIONS WERE OUTDATED AND NEEDED TO BE UPDATED FIRST. EMPLOYEES, ALONG WITH THEIR SUPERVISOR, WILL BE ASKED TO PUT TOGETHER AND WRITE OUT THEIR JOB DESCRIPTIONS. THE SAMPLE PERFORMANCE EVALUATION FORM FROM MONROE COUNTY WILL BE SHARED WITH EMPLOYEES FOR THEIR FEEDBACK ALSO. THE UPDATED JOB DESCRIPTIONS ARE TO BE COMPLETE AND EMPLOYEE INPUT ON THE SAMPLE EVALUATION FORM SHALL BE READY FOR DISCUSSION/ACTION AT THE JUNE 28, 2016 COUNCIL MEETING.

A DISCUSSION WAS HELD ON GARBAGE CONTAINERS FOR MEMORIAL DRIVE FEDERAL HOUSING DUPLEXES. NO FURTHER ACTION WAS TAKEN.

A MOTION WAS MADE BY COUNCILMAN RUD WITH NO SECOND MOTION BEING MADE TO GO WITH JEFF JOHNSON FOR A STEEL ROOF ON THE POLICE STATION. COUNCILMAN RUD LATER RESCINDED THE MOTION. CITY ADMINISTRATOR DAN LAUERSDORF WAS ASKED TO GET A DETAILED BID FROM JEFF JOHNSON AND BRING IT TO THE JUNE 14, 2016 COUNCIL MEETING.

A MOTION WAS MADE BY COUNCILMAN SCHULTZ AND SECONDED BY COUNCILWOMAN LARSON TO PUT INTO POLICY THAT IF A MAILBOX IS DAMAGED AS A RESULT OF THE CITY SNOW PLOWING, THE CITY WILL REIMBURSE THE OWNER \$15.00. MOTION CARRIED.

MOTION CARRIED.

A MOTION WAS MADE BY COUNCILWOMAN LARSON AND SECONDED BY COUNCILWOMAN SMITH TO APPROVE TWO TEMPORARY CLASS "B" BEER PICNIC LICENSES FOR THE MONDOVI YOUTH BASEBALL ASSOCIATION (ONE FOR 5/25/16 THRU 6/07/16 AND ONE FOR 6/8/16 THRU 6/21/16. MOTION CARRIED.
